Dear Stakeholder:

The Mountain Valley Pipeline (MVP) project is a natural gas pipeline being designed to transport the abundant natural energy resources from the Marcellus and Utica regions, to the growing demand markets in the Mid-Atlantic and southeastern regions of the United States. The project is being developed by Mountain Valley Pipeline, LLC – a joint venture between EQT Midstream Partners, LP and NextEra US Gas Assets, LLC. The MVP will span approximately 300 miles from northern West Virginia to southwestern Virginia, and as an interstate pipeline will be regulated by the Federal Energy Regulatory Commission (FERC). An in-service date is targeted for the fourth quarter of 2018, at which time the MVP will be operated by EQT Midstream Partners, LP, the majority owner of the joint venture.

As proposed, the MVP is expected to be up to 42" in diameter, with the route designed to utilize as many existing transmission corridors as possible. Other facilities associated with the project will include up to four compressor stations that will be located along the pipeline as well as measurement, regulation, and other ancillary facilities required for the safe operation of the pipeline. During recent months, we have reached out to landowners along the proposed route, seeking permissions to conduct survey work in the following counties:

West Virginia: Braxton, Doddridge, Fayette, Greenbrier, Harrison, Lewis, Monroe, Nicholas, Summers, Webster, and Wetzel

Virginia: Giles, Franklin, Montgomery, Pittsylvania, and Roanoke

As an important stakeholder and community member, we want to keep you informed of the proposed schedule, as well as provide ways for you to stay engaged throughout the various stages of the MVP project. On October 31, 2014 the FERC approved our use of the pre-filing process and assigned the following Docket Number: **PF15-3**. Further information about the MVP project and the FERC process can be found in the attached material.

As part of our outreach efforts, we will host community open houses to introduce and discuss the proposed MVP project. While there will not be a formal speech or presentation during these open houses, you will have direct, one-on-one access to people who will listen to your ideas and answer your questions about the project. This is your opportunity to meet with members of the MVP project team, as well as talk with FERC representatives. You are invited to attend any of the community open houses as scheduled:

In October 2015, we plan to file the application for the Certificate of Public Convenience and Necessity with the FERC. This aspect of the FERC process can take up to 12 months or longer and construction cannot begin until the FERC issues this certificate, which will include an environmental analysis of the project. Upon receipt of the required regulatory approvals, as based on this timeline, we expect the MVP pipeline to be complete and in-service during the fourth quarter of 2018.

We are excited about this project and we encourage community members and stakeholders to attend the open houses to learn more about the benefits of bringing a reliable supply of natural gas to the southeast region. Mountain Valley Pipeline, LLC is dedicated to the safe, responsible, and environmentally conscious construction of our pipeline. We want our community members to understand the natural gas transportation process and feel confident in knowing that we are committed to the safety of our communities --- from the construction phase, through to the 24/7 monitoring of in-service operations.
