The open forum meeting will be held in the Board of Supervisors Board Room located at the Franklin County Government Center, 1255 Franklin Street, Suite 104, Rocky Mount, Virginia. Citizens are encouraged to stop by and review proposals for the new county Election Districts and provide appropriate comments. Maps will be available of existing and proposed County Election Districts.

The Franklin County Board of Supervisors will hold public hearings on **Tuesday, March 22<sup>nd</sup>, 2011**, at 6:00 pm. to consider the final submission of the Redistricting Plan with revisions and the re-establishment of all election districts, voting precincts, and polling places. The public hearings will be conducted in the Board of Supervisors Board Room, Franklin County Government Center, 1255 Franklin Street, Suite 104, Rocky Mount, Virginia.
