

NOTICE

EXISTING LAWS WILL REMAIN IN EFFECT AND WILL BE STRICTLY ENFORCED

- 1) FOR USE BY FRANKLIN COUNTY RESIDENTS ONLY. PROOF OF RESIDENCY MAY BE REQUIRED. (DRIVER'S LICENSE, VEHICLE REGISTRATION, PAID FRANKLIN COUNTY TAX RECEIPT)**
- 2) NEW TRAFFIC PATTERN WILL BE RESTRICTED TO ONE-WAY. PLEASE FOLLOW SIGNS AND ATTENDANT INSTRUCTIONS.**
- 3) CONTRACTOR AND COMMERCIAL WASTE BY CODE MUST BE TAKEN TO THE LANDFILL BY OWNER OR PRIVATE HAULER.**
- 4) ONLY RESIDENTIAL WASTE WILL BE ACCEPTED. NO HAZARDOUS, TOXIC OR MEDICAL WASTE. NO FREE LIQUIDS INCLUDING PAINT, STAIN OR OIL. (PAINT CAN BE BLOTTED OR DRIED IN CAN AND DISPOSED OF). NO SHINGLES OR ROOFING MATERIALS. TVS COMPUTERS AND OTHER ELECTRONICS CAN BE PLACED IN COMPACTORS.**

- 5) FURNITURE AND RESIDENTIAL BULK MATERIALS CAN BE PLACED IN ASSIGNED LARGE CONTAINER. ONLY SMALL AMOUNTS OF CONSTRUCTION/DEMOLITION DEBRIS ARE ALLOWED AND MUST BE ACCOMPANIED BY A COPY OF THE BUILDING /DEMOLITION PERMIT SHOWING THE HAULER AS BOTH OWNER AND CONTRACTOR. TRUCK AND TRAILER LOADS OF CONSTRUCTION/DEMOLITION MATERIALS MUST BE TAKEN TO LANDFILL.**
- 6) METAL AND LARGE APPLIANCES ARE ALLOWED IN DESIGNATED CONTAINER. TVS AND ELECTRONICS WILL GO IN COMPACTORS.**
- 7) TIRES MAY BE DISPOSED OF BY FRANKLIN COUNTY RESIDENTS ONLY AT POSTED RATES. PAYMENT BY MONEY ORDER OR GOOD PERSONAL CHECK – NO CASH OR CREDIT CARDS ACCEPTED. COMMERCIAL TIRE DEALERS OR HAULERS MUST GO TO THE LANDFILL.**
- 8) FRANKLIN COUNTY RESERVES THE RIGHT TO PROHIBIT ENTRY TO COLLECTION SITES DUE TO MISUSE OF COUNTY PROPERTY OR VERBAL ABUSE OF COUNTY PERSONNEL.**
