

This letter is in reference to the attached application for a special use permit for turning a single-family residence into a duplex structure. The zoning for this residence is currently A-1 agricultural. The original house was added onto by the previous owners, however, the two houses were not joined together by an entrance. The original side consists of 4 rooms, one of which is a kitchen. It also includes its own bathroom and two entrances. The addition includes one bedroom, one bathroom, and its own kitchen as well. Each side has hookups for a laundry room. There is a shared well and septic system, which by code, is big enough for a three-bedroom structure. A building permit has been applied for to add a second meter base/ power source to separate the structures. A separate special use permit application has also been filed to turn the original side into a short-term rental. Please see the attached application form as well as the concept plan.

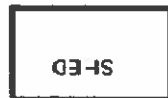

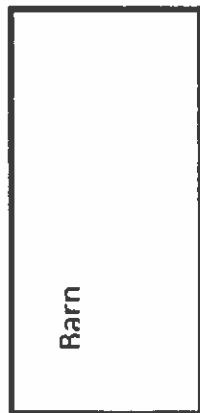

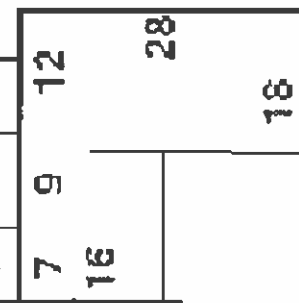
