Dear Franklin County Development Department,

Please consider this letter a formal Letter of Application for a Special Use Permit. The Special Use Permit is being requested for the renovation of an existing 22x22 feet enclosed garage on my single family dwelling property located at 550 Lakestone Rd. Union Hall, VA 24176 to a second dwelling structure for use by my mother.

I was raised in Danville, VA and purchased this property with my ex-husband in 2005. I have lived full time in this house since 2012 and am the sole owner of the property. My mother currently lives in an old farm-style home in Chatham Virginia which has steep stairs into each egress and step down and step ups throughout the house. It is also a very room divided home which would prove difficult for mobility when the use of a walker or wheelchair is needed.

My mother will be 91 years old in March, continues to live independently but is beginning to struggle with barriers such as stairs, excessive activity and maintenance of her home. My mother is not interested in living with any of her four children as she enjoys her independence. I have no intention of modifying the ambiance/appearance of my property or neighborhood and believe for all intents and purposes, the landscape changes of this project is minimal.

I work remotely from my home and it seems a viable and attractive option to convert my existing garage into a single level apartment for my mother. This would maintain her independence while also allowing connection and availability should she need assistance. The existing garage sits on a concrete slab and measures 22x22 feet. It sits far from the lake's edge and is behind my existing home (a geodesic dome). I am proposing extending the 22x22 foot garage by ten feet in an easterly direction (deeper into my property) making the new apartment measurements 22x32. This will be a one bedroom/one bath, living room and kitchen area apartment. There is existing AEP transformer box on my property between my home and the existing garage which can be utilized to provide upgraded electricity to the renovated garage. I am also proposing the placement of a one bedroom septic system to be connected to the apartment as part of this project. I believe the septic system will easily be placed in the wooded area behind or next to the apartment/existing garage.

My home is provided water through Western Water Authority and I have access pipes existing from Lakestone Rd to my home. The plan is to have water accessible to the apartment via this existing pipe system or whatever is recommended from Western Water Authority.

I have spoken to both my immediate neighbors who are both supportive of this project and who will be providing Letters of Support to the Department. I appreciate your consideration in this matter and am available to speak with any Franklin County representative as needed.




